## RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, ESTABLISHING A FRAUD REWARD PROGRAM

WHEREAS, the Board of Supervisors of the County of Los Angeles is deeply concerned about fraudulent activities perpetuated against the County of Los Angeles; and

whereas, the Board of Supervisors desires to authorize rewards up to \$1,000 for information resulting in a criminal conviction of person or persons committing fraudulent activities against the County of Los Angeles; and

WHEREAS, the Board of Supervisors wishes to state the terms, conditions and manner of payment of said reward;

NOW, THEREFORE BE IT RESOLVED by the Board of Supervisors of the County of Los Angeles, State of California, as follows:

SECTION 1. The Chief Administrative Officer, the County Counsel, and the Auditor-Controller, or representatives of the above officers, shall review any applications for payment of the above rewards. Upon such review, they shall make recommendations to the Board of Supervisors as to the payment of these rewards or any

part thereof to any person or persons. Said recommendations may include a determination that the reward should be apportioned between various persons.

SECTION 2. The Board of Supervisors shall receive and review such recommendations and after such review it may, in its absolute discretion, order payment of the above rewards or any part thereof to any person or persons as it deems fit.

SECTION 3. Each reward may not exceed \$1,000. This resolution shall constitute the exclusive manner under which payment of said reward may be claimed and made. This resolution shall remain in effect until further action by the Board of Supervisors.
